### BOOKING CONDITIONS

Any acceptance of your booking will be subject to the following conditions:

- **BOOKING FORM:** All bookings must be on the official booking form and completed and signed by the person who is responsible for the booking (provisional booking may be made by phone but we must receive deposit within 10 days).
- **DEPOSIT:** A deposit of 40% per person is the booking fee and forms part of the payment of the programme. The deposit must be received before the reservation can be confirmed. YOUR DEPOSIT IS NON-REFUNDABLE & NON-TRANSFERABLE
- **PAYMENT OF BALANCE:** Must be received 4 weeks prior to date of arrival. Non-compliance with this condition will result in automatic cancellation and forfeiture of deposit.
- **LATE BOOKING:** A booking made on a date less than 4 weeks prior to commencement date of booking must be accompanied by payment of the full amount before booking can be confirmed.
- **CANCELLATION:** In the event of any confirmed booking being cancelled - 4 weeks or less prior to commencement date of booking - the amount in full will be forfeit. Deposit is non refundable.
- **RIGHT TO DECLINE:** Carlingford Adventure Centre has the right to decline a booking for any reason.
- **RIGHT TO CANCEL:** Carlingford Adventure Centre reserves the right to cancel a programme should a participant prove to be difficult or pose a danger to other members of the group or staff.
- **RIGHT TO RESCHEDULE:** Inclement weather conditions may cause us to cancel or re-arrange a programme.
- Persons participating in activities do so voluntarily & at their own risk & no claims shall be made against Carlingford Adventure Centre in respect of injury or loss arising there from. Participants are, therefore, advised to obtain their own personal accident or other insurances.
- **PANDEMIC:** In the event of bookings being cancelled due to a lockdown caused by COVID-19 or another pandemic any payment you have made to us prior is secured. You will receive a voucher for the monetary value to be used on an alternative suitable date. No refunds are available but booking credit will be honoured for up to two years from the date of payment.
