The total number of people staying at each holiday home must not exceed the capacity of the house. It is important that you confirm the exact number in the party on arrival (details shown above).

DEPOSIT: A non-refundable 50% booking deposit (or a minimum of €200) is required to confirm your Holiday Home booking & the balance is due 3 weeks prior to arrival. Deposit of 50% is non refundable but may be used at a later stage.

ADVENTURE ACTIVITIES: A 40% deposit per person is required for activities. This is NON-REFUNDABLE and non-transferable. Full Payment and confirmation of final numbers is required 3 weeks prior to arrival. Payment is non refundable

CANCELLATIONS: In the event of a cancellation, the following charges will apply:

- * 6 weeks prior to arrival; you will forfeit your deposit
- * Within 3 weeks of arrival; you will forfeit full booking fee.

Check in time: 6pm but an earlier time can be requested (Not available During July & August)

Check out time: 12 Noon but a later Departure of 2pm can be requested – Surcharge €100. (Not Available During July & August.)

- During the Months of July & August if both Adults & Children are doing activities please note check out time is 9.00am & a baggage store will be provided at Carlingford Adventure Centre.

KEY COLLECTION: Please contact Carlingford Adventure Centre (00353 42 93 73100) 24 hours before your arrival to arrange key collection. Please advise of any delay.

- A €50 key deposit is required on collection of each key.

SECURITY DEPOSIT: On Check in a credit card will be pre-authorized with a €200 security deposit or €250 to include the key deposit for any damages. An inventory has been taken of every item in each house and priced accordingly. The security deposit will not be taken from you once the site manager is satisfied that the property is left in order. If the property is not left in a clean & tidy condition, a security deposit may be retained.

- Any breakages should be reported & paid for on departure. Excessive damage to any property will be the responsibility of the person who made the booking.
